What is the product?

The SWORD MULTI-ASSET FUND is an open-ended investment compartment (the "Investment Compartment") of PHOEBUS RAIF V.C.I.C. PLC. (the "Fund Company"). The Fund Company is a private company limited by shares incorporated under the Companies Law, Cap. 113, under registration number HE454636 and registered with CySEC as a RAIF operating as a variable capital investment company, which will act as an open-ended Registered Alternative Investment Fund ("RAIF") in accordance with the provisions of Part VIII of the AIF Law or any other law which replaces or amends it addressed to Professional and/or WellInformed investors notifying the CySEC of its activities as a RAIF and pursuant to the Company's registration as a RAIF in CySEC's RAIF Register. The Fund is established as an umbrella structure with multiple Investment Compartments with segregated liability between these Investment Compartments. Any active Investment Compartments launched by the Fund are and will be documented in the Prospectus and its Supplement(s). The Fund Company is externally-managed by WEALTH FUND SERVICES LTD (the "External Manager"), a private company limited by shares which operates as a UCITS and AIF Management Company, under license number MC UCITS 6/78/2012 (updated to include AIFs on 17.07.2020).

Duration

This investment has no maturity date. There are circumstances under which the Company may be entitled to terminate the investment in the Investment Compartment unilaterally. Circumstances under which the termination of the investment can occur include, inter alia, the investment being held by or for the benefit (directly or indirectly) of an ineligible investor or being acquired in breach of any applicable laws or the termination of the investment would eliminate or reduce the exposure of the Company to any tax and/or regulatory adverse consequences.

Objectives and Investment Policy


The main objective of the Investment Compartment is to deliver medium to long term returns from capital gains and income, investing in securities. In order the Compartment to achieve its respective investment objective, the External Manager has established structured and appropriate investment strategies. The Investment does not have a predominant investment strategy. To this end, the investment strategies of the Investment Compartment are best described as equity investment strategies complemented by the contribution of fixed income strategies. The External Manager will adopt a flexible asset allocation strategy for the Investment Compartment through investing in a diversified portfolio of various types of asset classes, including but not limited to deposits, fixed income securities, equity securities, and alternative investment assets based on fundamental and technical analysis. The Investment Compartment may gain exposure to these asset classes directly or indirectly through investing in funds and other collective investment schemes. The Investment Objective and Strategy and subject to the investment restrictions as further detailed in the relevant Prospectus Sections and any Supplements attached. Overall, the Investments of the Investment Compartment shall at any time comply with the policy set out in the relevant Fund Company Prospectus and Supplement(s) and Investors prior to making any investment should take due account of the risks of Investing in the Investment Compartment as set out in section "RISK DISCLOSURES" of the Prospectus and its Supplements.

Other information

What are the risks and what could I get in return?



The risk indicator assumes you keep the Product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The SRI is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7 which is a 'medium-low' risk category. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the capacity to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment.

The following are additional risks materially relevant and not covered by the risk and reward category:

Country Risk/Sector Risk/Issuer Risk/Currency Risk

The risk of investing or having exposure in a specific country, sector, issuer and currency which depends on political, legal, economic and social risks of that country, the prospects of the specific industry sector within the country and the business prospects and financial position of any particular issuer within the sector. Moreover, any pertinent investment may carry different currency risk depending on the jurisdiction of issuance.

Market Risk

The risk of loss resulting from fluctuation in the market value of positions in the portfolio attributable to changes in market variables, such as interest rates, foreign exchange rates, equity and commodity prices or an issuer's creditworthiness.

Operational and Safekeeping Risks

The risk of loss resulting from inadequate internal processes and failures in relation to people and systems of the External Manager or from external events, and includes legal and documentation risk and risk resulting from the trading, settlement, safekeeping and valuation procedures.

Impact of Financial Techniques

The risk of loss resulting from utilizing specific derivatives on financial instruments which are intensified by the leverage structure of these products (e.g. fluctuation of the underlying asset, counterparty risk in the case of over-the-counter transactions, liquidity, etc.).

Liquidity Risk

The risk that a position in the portfolio cannot be sold, liquidated or closed at limited cost in an adequately short time frame and that the ability to redeem shares at the request of an investor is therefore compromised.

Performance Scenarios

The unfavourable, moderate, and favourable scenarios shown below are illustrations using the worst, average, and best performance of the Product. The stress scenario shows what you might get back in extreme market circumstances. What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

This table shows the money you could get back over the next 1 or 3 years, under different scenarios, assuming that you invest 10.000 EUR. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the product. The figures shown include all the costs of the product itself but may not include all the costs that you pay to your advisor or distributor. This means it is difficult to estimate how much you would get back if you are willing to cash in before the recommended holding period (3 years). You will either be unable to cash in early or you will have to pay high costs or make a large loss if you do so. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The unfavourable scenario occurred for an investment between December 2021 - December 2022 (if you exit after 1 year) and between December 2021 - December 2023 (if you exit after 3 years).

The moderate scenario occurred or an investment between April 2021 - April 2022 (if you exit after 1 year) and between October 2020 - October 2023 (if you exit after 3 years).

The favourable scenario occurred for an investment between March 2020 - March 2021 (if you exit after 1 year) and between December 2018 - December 2021 (if you exit after 3 years).

What happens if the compartment is unable to pay out?

In the event of default of the Compartment, there will be a direct impact on investors. Deposits by collective investment schemes are excluded from the Cyprus Deposit Guarantee and Resolution of Credit and Other Institutions Scheme. The investors in the Compartment are protected by any investor compensation or guarantee scheme.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you wit h information about these costs and show you the impact that all costs will have on your investment over time.

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account, one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for one holding period. The figures assume you invest 10.000 EUR. The figures are estimates and may change in the future.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different investment periods. In case you decide to exit before the product ends, exit costs may apply in addition to the amounts shown here.

We have assumed

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding period we have assumed the Product
 performs as shown in the moderate scenario.
- 10.000 EUR is invested.

(*) This illustrates how costs reduce your return each year over the holding period. For example, it shows that if you exit at maturity your average return per year is projected to be 14.4 % before costs and 12.2 % after costs.
